ORDINANCE NO. 2 of 2017

**AN ORDINANCE REQUIRING ACCOUNTABILITY OF ORGANIZATIONS IN  
THE BOROUGH USING "JERMYN" IN THE ORGANIZATION'S NAME**

By the powers granted to the Borough of Jermyn by the Pennsylvania Borough Code, 8 Pa.C.S.A. § 101 et seq., be it ENACTED and ORDAINED by the Borough Council of the Borough of Jermyn, Lackawanna County, Pennsylvania, and it is hereby ENACTED and ORDAINED by the authority of the Jermyn Borough Council as follows:

**SECTION 1: DEFINITIONS**

**"Borough"** shall mean the Borough of Jermyn, Pennsylvania.

**"Organization"** shall mean any team, club, group, committee or other organized group of individuals within the Borough using the Borough name as part of the Organization name.

**"Officers"** shall mean persons having a title in the Organization in a position of command or authority.

**"Financial Report"** shall mean a formal record of the financial activities and financial position of the organization to include balance sheets, assets, liabilities, revenue, debts, etc.

**"Borough Assets"** shall mean any property and/or real estate owned by the Borough.

**SECTION 2: APPLICATION**

On January 1st and July 1st of each calendar year, any Organization in the Borough using the Borough's name as part of the Organization's name shall provide to Borough Council a list of the Officers of the Organization and the Financial Report of the Organization.

**SECTION 3: PENALTIES**

Any Organization who violates any term, provision and/or requirement of this Ordinance shall have suspended its entitlement to the use of Borough assets until it is in full compliance with all terms, provisions and/or requirements of this Ordinance.

**SECTION 4: SEVERABILITY**

If any section, clause, provision, or portion of this ordinance shall be held invalid or unenforceable by any court of competent jurisdiction, then such decision shall not affect any other section, clause, provision, or portion of this ordinance so long as it remains legally enforceable without the invalid

portion(s). The Borough Council reserves the right to amend this ordinance, or any portion thereof, from time to time as it shall deem necessary to further the purposes of this ordinance and the effective administration thereof. Any such amendments shall be made in accordance with the requirements of the Pennsylvania Borough Code, 8 Pa.C.S.A. § 101 et seq.


**SECTION 5: EFFECTIVE DATE**

This ordinance shall become effective upon enactment.




